PAKISTAN PENAL CODE (ACT XLV OF 1860)

A magistrate, with the powers underlined in section 30 of the Criminal Procedure Code (Cr.P.C.), has the jurisdiction to hear all criminal matters other than those which carry the death penalty (such as attempted murder, dacoity, robbery, extortion, etc.), but may only pass a sentence of up to seven years' imprisonment.
